

ARTICLE I. NAME

The name of the non-profit corporation is **WE NEED YOU FOUNDATION, INC.**

ARTICLE II. PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III. PURPOSE

This corporation is organized for the purpose providing financial assistance in the form of housing, products and or services to physically and mentally handicapped persons with the intention to qualify for section 501 (c) status of the Internal Revenue Code.

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

Except as otherwise provided by law, the entire voting power for the election of directors shall be outlined in the bylaws of the corporation.

ARTICLE V. LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302 Florida Statutes.


ARTICLE XII MEMBERSHIP


