THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION, PURSUANT TO CHAPTER 617, FLORIDA STATUTES, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION.

ARTICLE I  
CORPORATE NAME

THE NAME OF THE CORPORATION IS LIGHT AND LIFE MINISTRIES, INC., AND THE INITIAL ADDRESS OF THIS CORPORATION IS 400 SOUTH FLORIDA AVENUE, LAKE LAND, FLORIDA, 33801.

ARTICLE II  
TERM OF EXISTENCE

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE UNLESS DISSOLVED ACCORDING TO LAW. CORPORATE EXISTENCE SHALL COMMENCE UPON THE FILLING OF THESE ARTICLES OF INCORPORATION WITH THE SECRETARY OF STATES OFFICE.

ARTICLE IV  
ACTIVITIES

NO PART OF THIS CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTED TO THE MEMBERS, TRUSTIES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND

TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE TO THE PURPOSES SET FORTH IN ARTICLE III THEREOF. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE IN OR INTERVENE IN, (INCLUDING THE PUBLICATION OR DISTRIBUTION OF STATEMENTS), ANY POLITICAL CAMPAIGN ON THE BEHALF OF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON

(A) BY A CORPORATION EXEMPT FROM THE FEDERAL INCOME TAX UNDER SECTION 501 (C) 93) OF THE INTERNAL REVENUE CODE OR CORRESPONDING SECTION OF ANY FURTHER TAX CODE, OR,

(B) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 107 (C) (2) OF THE INTERNAL REVENUE CODE OR CORRESPONDING SECTION OF ANY FURTHER TAX CODE.

ARTICLE V  
DISSOLUTION




