I respond to your letter of 1 March regarding DeRosa Civic Association, Inc.

- 1. Regarding your paragraph on the manner in which directors are elected:
 I refer you to Page 5, Article V of the proposed document. I also refer you to SS 41.61, Florida Forms, .page 576, Article 6, Governing Body, for model language, from which we took our language. We trust this meets your objection.
- 2. Regarding the purpose of this association, I also refer you to Florida Forms, SS 41:61, page 575, Article 3. Our language was taken from that publication.

The organization is deep in the throes of its purpose, i.e., "the betterment of the, environmental,..... atmosphere and circumstances, etc." to keep Tampa Bay from removing water from this part of Citrus County. That is not the organization's only purpose, and only seriously came into focus after Florida Power published its study on the removal of water from Lake Rousseau (located in District One of Citrus County) and piping it to Tampa/St Pete. Regardless, if you would look at the copy I've included of pages 575 and 576 of Florida Forms, you will see our language. We have no claim to originality, only to the tailoring of the recommended format to our particular circumstance in life.

The forms I am advised are generally approved by the Supreme Court of the State of Florida. I respectfully request that the document be registered as submitted.



ARTICLES OF INCORPORATION OF DEROSA CIVIC ASSOCIATION, INC., a not for profit corporation.



To further common purposes, the members agree to organize under these Articles of incorporation of an association.

Article L Name

The name of this corporation shall be DEROSA CIVIC ASSOCIATION, INC., a not for profit corporation.

Article II. Principal Office

The principal office of the association shall be at 6081 West Caruso Court, Dunnellon, FL 34433.

Article III. Purposes

The purposes for which this association is formed are:

- A. To own, operate and maintain an association exclusively for the betterment of the civic, environmental and political atmosphere and circumstances of the members hereof.
- B. To function on behalf of the members of the association to improve the lifestyle, community, living conditions, health, safety, welfare, pleasure, entertainment and recreation of the members.

C To do anything necessary, proper and legal for the accomplishment of any purposes established now or in the future for the association.

D. This association is organized and operated exclusively for the above-stated purposes, and for other not-for-profit purposes. No part of any net earnings shall inure to the benefit of any private member, except as may be necessary for the well being of such member in a time of need.

Article IV. Powers

In furtherance of the objectives described above, nut not in limitation thereof, the association shall have the power, insofar as such power is conferred, or is not limited by law, to make and perform contracts for any lawful, purpose, to engage in various funding and fund-raising activities and to acquire, own, hold, operate and maintain such property as to effectuate its purposes. In addition, this association shall have the power to:

- A. Have succession by its corporate name for the period set forth in these its articles of incorporation.
- B. Sue and be sued and appear and defend in all actions and proceedings in its corporate name to the same extent as a natural person.
- C. Adopt, use, and alter a common corporate seal. However, such seal must always contain the words "corporation not for profit."

- D Elect or appoint such officers and agents as its affairs shall require and allow them reasonable compensation.
- E. Adopt, change, amend and repeal bylaws, not inconsistent with law or its articles of incorporation, for the administration of the affairs of the corporation and the exercise of its corporate powers.
- F. Increase, by a vote of its members case as the bylaws may direct, the number of its directors so that the number shall not be less than three (3) but may be any number in excess thereof.
- G. Make contracts and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage and pledge of all or any of its property, franchises, or income.
- H. Conduct its affairs, carry on its operations, and have offices and exercise the powers granted by law in any state, territory, district, or possession of the United States of America or any foreign country.
- I. Purchase, take, receive, lease, take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use or otherwise deal in and with real or personal property, or any interest therein, wherever situated.
- J. Acquire, enjoy, utilize and dispose of patents, copyrights and trademarks and any licenses and other rights or interests thereunder or therein.

K Sell convey, mortgage, pledge, lease, exchange, transfer or otherwise dispose of all or any party of its property and assets

L. Purchase, take, receive, subscribe for or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of and otherwise use and deal in and with, shares and other interests in or obligations of other domestic or foreign corporations, whether for profit or not for profit, associations, partnerships, or individuals or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, municipality, or of any instrumentality thereof.

M. Lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds loaned or invested except as prohibited by law.

N. Make donations for the public welfare or for religious, charitable, scientific, educational, political or other similar purposes.

- O. Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the corporation is organized.
- P. Merge with other corporations both for profit and not for profit, domestic and foreign, if the surviving corporation is a corporation is a corporation not for profit

Article V Membership

- A The association shall have one class of members only. All voting rights and other rights, interests and privileges of each member shall be equal.
- B. The rights and privileges of members, their liability for dues and assessments and the termination and transfer of membership shall be as stated in the by-laws.
- C. Membership is open to all adult residents of District One of Citrus County, FL and all businesses residing or located or function within the boundaries of District One.

Article VI Governing Body

The powers of the association shall be exercised and its property controlled by the Board of Directors. The qualifications, the time and manner of election, the terms and duties of office and the manner of filling vacancies shall be set forth in the by-laws.

Article VII Officers

A. Elective Officers. The officers of this association shall be a president, vice president, secretary and treasurer. Other offices and officers may be established or appointed by members of the association at the regular annual meeting. The qualifications of, the time and manner of electing, the duties of, the terms of office of, and the manner of removing officers shall be as set forth in the by-laws.

Article VIII Amendments to Articles

These articles may be amended or repealed, in whole or in part, only by majority vote of this association's members at an organized meeting of the association.

Article IX By-Laws

By-laws will be hereafter adopted. Such by-laws may be amended or repealed, in whole or in part, in the manner provided in the by-laws, and the amendments to the by-laws shall be binding on all members, including those who may have voted against them.

Article X Duration

This corporation's existence shall be perpetual.

Article XI Dissolution

This association shall be dissolved and its affairs wound up by a three-fifths majority vote of the association's voting members or when the objectives for which the association is organized have been fully accomplished.

Article XII Distribution of Property on Dissolution

In the event of dissolution, property of the association shall either be distributed directly to another not-for-profit corporation, or shall be sold and the proceeds therefrom be distributed to a not-for-profit corporation for their exclusive use and benefit. The course to be followed will be established by three fifths majority vote of the then active membership of the association.
