OF

ARTICLE I. NAME

The name of this Corporation is BEAR BAY HUNTING CLUB,

ARTICLE II. ENABLING LAW

This corporation is organized pursuant to the Corporations Not for Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

ARTICLE III. PURPOSE

The purpose of this Association is to promote the sport of safe hunting among friends and associates; wildlife management; fire control; appreciation of resources; educate members, and any other legal activity under the laws of the State of Florida.

ARTICLE IV. TERM

This Corporation shall have a perpetual existence.




