ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation not for profit pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation.

ARTICLE I

The name of this corporation shall be KIWANIS CLUB OF NEW TAMPA, INC. The mailing address of this corporation shall be:

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The purposes of the Kiwanis Club of New Tampa, Inc. are:

1. To give primacy to the human and spiritual rather than to the material values of life.
2. To encourage the daily living of the Golden Rule in all human relationships.
3. To promote the adoption application of higher social, business, and professional standards.
4. To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
5. To provide through this club, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
6. To cooperate in creating and maintaining that sound public opinion and idealism which makes possible the increase of righteousness, justice, patriotism, and goodwill.
7. For the purposes aforesaid, to take over the assets, right and franchises of

the unincorporated club, known as the Kiwanis Club of New Tampa, and its members.

8. To do all such things as are incidental or conducive to the attainment of the above objects.

#### ARTICLE IV

The qualifications of members and the manner of their admission shall be in accordance with the provisions set forth in the Bylaws.

#### ARTICLE V

These Articles may be amended by a two-thirds vote of the membership of the corporation at a duly noticed meeting.




### Designation and Acceptance of Registered Agent
