ARTICLES OF INCORPORATION

OF.

BY THESE ARTICLES OF INCORPORATION, the incorporators form a corporation under Florida law.

ARTICLE I

The name of the corporation is Consumer Resource Institute, Inc.

ARTICLE_II

The corporation shall exist perpetually.
