Articles of Incorporation

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

Article I

Name of the Corporation.

Article III

Purpose.

This corporation is organized as a non-profit corporation according to article 501(c)3 of the Internal Revenue Code for the purpose of serving as the Foreign Mission Society for the Charismatic Episcopal Church of North America and its international communion of churches. As such, it will perform all functions relevant to the propagation of its Christian faith through missionary activity including the establishment of its churches throughout the world and all other things necessary and proper in the pursuit of such purposes.

Article IV

Manner of Election of Directors and Officers.

Directors are appointed by the supervising bishop according to the methods set forth in the bylaws of the corporation. Officers of the corporation will be appointed by the Directors.


