Articles of Incorporation

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Floritla Statines adopt the following Articles of Incorporation:

Article I

Name of the Corporation.

Purpose.

This corporation will be subordinate to and subject to the authority of the Charismatic Episcopal Church of North America.
