The undersigned subscriber to these Articles of incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutos.

ARTICLE 1 - NAME

The name of the corporation in Spanish is MINISTERIOS UNIDOS EN JESUCRISTO, INC., it is translated in English to UNITED MINISTRIES IN JESUS CHRIST, INC.

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 3 - PROHIBITIONS
