## ARTICLES OF INCORPORATION

FILED CICRETARY OF STATE DIVISION OF CORPORATIONS

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, residents of the State of Florida, desiring to form a not-for-profit corporation under Chapter 617, Statutes of the State of Florida and the amendments thereto, do, for the purposes and objects hereinafter stated, hereby associate ourselves with the intention of forming such corporation, and do hereby agree and declare:

I

The name of this corporation shall be "INVERNESS LIONS CHARITIES, INC. ".

ΙI

- The purposes and object of this corporation shall be:
- 1) To cooperate with all existing recognized agencies rendering service to the Blind and Sight Impaired along with the Deaf and Hearing and Speech Impaired and other Charitable, Educational or Scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954.
- 2) To solicit, collect, and otherwise raise money for charitable purposes; to expend, contribute, disburse, and otherwise handle and dispose of the same for such purposes either directly or by contributions to needy individuals, or to other agencies, organizations, or institutions organized for the same or similar purposes, and for the planning, development and maintenance of a unified program for the providing of service to persons in need.
- 3)To initiate, sponsor and support public information programs to eliminate, prevent or avoid conditions, accidents, disease or other factors responsible for or contributing to loss of sight, hearing and speech; and wherever possible, for the improvement and conservation of Sight, Hearing and Speech of Humans.
- 4) To open to all Sight, Hearing and Speech Impaired and other qualified persons, all possible avenues of employment and livelihood.
- 5) To provide, where possible, recreational and social facilities and opportunities for the Sight, Hearing, Speech Impaired and other qualified persons, and to aid them in fitting into the community as normal, contributing and respected citizens.

- 6) To stimulate and encourage in the public at large, an understanding and interest in the Sight, Hearing and Speech Impaired and in other qualified Charitable, Educational or Scientific organizations, and in the objects and purposes of the Corporation; and to give an opportunity to the public at large to participate in programs for aid and assistance to those qualified, through personal service, membership in the Corporation, donations, contributions, bequests or devises of property or money, for the exclusive use as expressed in these objects.
- 7) To generally do, perform and carry on all the matters, acts, things and business transactions necessary to the objects and purposes of the Corporation and for such other objects and purposes of specific nature not hereinabove particularly set forth as are usual and proper in connection with corporations not for profit, and as authorized under and by virtue of the Laws of the State of Florida now in existence or which may hereinafter be enacted.
- 8) The Corporation specifically shall not have as its purposes, any purpose circumscribed or requiring the approval of the Florida Department of Health & Rehabilitative Services or the Florida Department of Education. The educational activities shall be limited to providing and sponsoring information regarding matters as hereinabove provided.
- 9) Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code 1954, (or corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

#### III

The office of the corporation shall be located in Citrus County, Florida. The street address of its principal and registered office is 5976 E. Dell Lane, Inverness Florida 34452 and the name of its registered agent is Raymond J. Wojciulewicz.

#### ΙV

The Corporation shall have eleven Trustees. The names and addresses of the Trustees for the first year, which year shall run concurrent with the fiscal year of the Lions Club of Inverness, of this Corporation are as follows:

The Trustees of this Corporation shall be the Officers and Directors of the Lions Club of Inverness, Florida, excepting the Tail Twister, Lion Tamer and Membership Director, and their term as Trustees in this Corporation shall be concurrent with their terms of office in the said Lions Club of Inverness.

VI

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, trustees, officers and/or other private person, except that the corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes for which the corporation is organized. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting

to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf or any candidate for public office.

This corporation shall have no capital stock and shall not engage in business for profit, but shall be supported gifts, bequests, benefits, contributions. Membership in the corporation shall be governed and controlled provided in the Constitution and By-Laws of this corporation.

#### VII

Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all the assets of the Corporation exclusively for the purposes of which the Corporation was formed, in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or scientific purposes as shall at the time qualify as an exempt organization or organization. at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law) as the Trustees shall determine. Any of the assets not so disposed of shall be disposed of as provided under the Statutes of the State of Florida exclusively for such purposes Statutes of the State of Florida, exclusively for such purposes or to such organization or organizations as shall be thereby determined, which are organized and operated exclusively for suci purposes.
