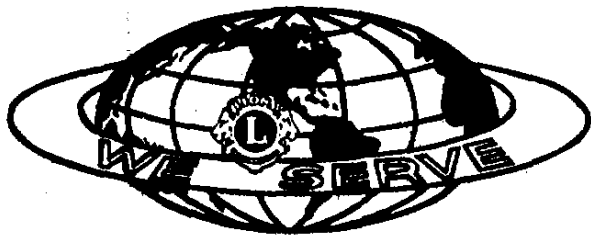

All of our funds collected from fund-raising activities go to provide eyeglasses and sight restoration and various other charities with some going to obtain fund-raising equipment. We provided 19 eye exams and eyeglasses to the people of Inverness who would not be able to purchase them. We referred 3 people to Florida Foundation for the Blind with \$100.00 contribution being given toward their surgery.

We have had a booth at the Citrus County fair, where we sold raffle tickets for a cruise and dispersed literature for the public regarding preservation of sight, donor cards, hearing aid literature and information about Lions International and the areas we support. We held a health fair where other charitable organizations and local businesses could provide helpful information for the local community and referrals to appropriate organizations for help regarding speech, hearing and sight impairment or physical needs.
