## ÄRTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF HUNGTINGTON POINTE HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of §617.1006, *Fla. Stat.*, Huntington Pointe Homeowners Association, Inc. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

#### FIRST: Amendment adopted:

Article VII and Article X of the Articles of Incorporation of Hungtington Pointe Homeowners. Association, Inc. are hereby amended as follows (additions are indicated by underlining; defetion are indicated by strike-outs, omitted and unaltered provisions are indicated by ellipses):

#### ARTICLE VII BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of three (3) a minimum of five (5) and a maximum of seven (7) Directors, who need not shall be members of the Association. The number of directors may be changed by amendment of the Bylaws of the Association. The Board of Directors shall be elected at the First meeting of the Association in the manner described in the Bylaws.

### ARTICLE X AMENDMENTS

The Association shall have the right to amend these Articles at any time upon the affirmative vote of two thirds (2/3) of the voting interests of the Association as described in Article VI hereof not less than two-thirds (2/3) of the total votes of the Association whose Owners holding such interests are voting in person or by proxy at a meeting at which a quorum has been attained (e.g., once a quorum has been obtained at a meeting of the Members of the Association, two-thirds (2/3) of those voting interests attending the meeting in person or by proxy may amend these Articles). Alternatively, these Articles may be amended by an instrument signed, or otherwise consented to in writing, by Owners holding not less than a majority of the votes of the Association. Amendments may be proposed by resolution approved by a majority of the Board of Directors; provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of the members, without approval in writing by all members and the joinder of all record owners of mortgages upon the Lots. No amendment shall be made that is in conflict with Florida law or the Declaration unless the latter is amended to conform to the same.
