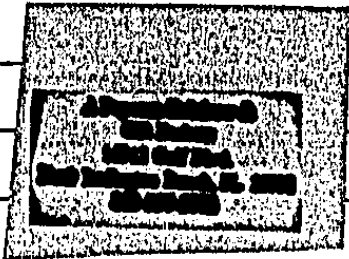

A Not-For-Profit Corporation

I, the undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby make, subscribe, acknowledge and file this certificate for the purpose of becoming a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME OF CORPORATION

The name of this corporation is:

BARRIER REEFS TURTLE WATCH, INC.

ARTICLE II

PURPOSE

The nature of the business and the purposes for which this corporation is organized are as follows: to perform scientific research and the care and maintenance of sea turtles and other sea mammals, advertising and all other activities which are necessary, suitable or convenient for the accomplishment of the foregoing purposes or which are incidental thereto or connected therewith and to conduct business and carry out all of the aforesaid purposes in any state, territory, district or possession of the United States, to the extent not forbidden by law; to have any and all rights, powers and privileges, which are or may be granted, to such corporations incorporated under the laws

of the State of Florida.

ARTICLE III

TERMS OF EXISTENCE

This corporation is to have perpetual existence.

ARTICLE IV

INITIAL REGISTERED OFFICE

of this State or of the United States.




