The undersigned, in accordance with the provisions of Section 617.013, Florida Statutes, hereby makes, subscribes and files these Articles of Incorporation for the purpose of forming a corporation not-for-profit.

ARTICLE I: NAME

The name of the corporation shall be: PUBLIC LANDS PRESERVATION SOCIETY, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 718 S.W. Second Court, Fort Lauderdale, Florida 33312.

ARTICLE III: INITIAL REGISTERED AGENT

The name of the initial registered agent of the corporation is CARRIE BOOTSMA and the address of the initial registered office is 718 S.W. Second Court, Fort Lauderdale, Florida 33312.

ARTICLE IV: EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V: PURPOSE

The purpose and objects for which this Corporation is organized and the general nature of the business to be transacted shall be to:

A) Foster and promote the best interests of the public lands of Broward County:

B) To promote and strive for the preservation, improvement and betterment of all public lands, encourage a better community and civic spirit, to foster goodwill, cooperation, and friendship between and among all of the residents of said area:

C) To otherwise promote and encourage a balanced quality of life in Broward County.

ARTICLE VI: MEMBERSHIP

The membership of this Corporation shall consist of the undersigned subscriber and such other individuals or groups expressing an interest in promoting the preservation of public lands and they shall hereafter be elected to membership in this Corporation by its Board of Directors. All membership in this Corporation shall continue until terminated in such manner as may be provided by the By-Laws of this Corporation.

ARTICLE VII: AFFAIRS

The affairs of the corporation shall be managed by a Board of Directors, and by such other officers as shall be elected or appointed in such manner as the Board of Directors shall prescribe.

ARTICLE VIII: MANNER OF ELECTING DIRECTORS

The Board of Directors of this Corporation shall be comprised of three (3) initial members who are so appointed and will be subject to election as provided in the corporate By-Laws. Dear Susan Payne:

I have just learned that my name still has not been removed as a member/director of the Public Lands Preservation Society. This was going to be done, I believed, by the current members. I am also wondering how my name was included in the annual re-file applications, due every May 1. I did not sign any applications, except for the initial one. However, I resigned from the group on July 8, 1993.

If my name was included in any new filings, it was done so without my knowledge or consent.
