



Gentlemen:

In accordance with a conversation between myself and Andy from your Reinstatement Department, I am writing to request your consideration for the waiver of the \$175.00 reinstatement fee for our Property Owners Association, a non-profit organization.

The basis for this request is that at NO time since 1995 were we advised that an annual fee was due to continue our incorporation status. As the Registered Agent, and President of the SADDLE TRAILS PARK PROPERTY OWNERS ASSOCIATION, I should have been notified of any delinquent fees. Additionally, I was quite surprised to learn of the State's dissolution of our Association while I was making an inquiry of a totally unrelated matter. Therefore, Andy, your representative, felt our request for waiver of the reinstatement fine had merit and advised me to submit \$122.50 to cover the past due fee for 1996 and the current annual fee for 1997, as well as \$8.75 to receive a Certificate of Status. Any additional penalties imposed on our Association would create a severe financial hardship as our annual dues are minimal.

Since we are dedicated to continuing our volunteer work in the Community, it is imperative that we be allowed to remain a non-profit incorporated association and we appreciate you granting this waiver request.
