**ARTICLES OF INCORPORATION**

***Article I***

***Name***

The name of the corporation shall be: Sunrise Le Tip, Inc.

***Article II***

***Principal Place of business and mailing address***

The principal place of business and mailing address of this corporation shall be:

***Article III***

***Purpose***

A. This corporation is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law of 1988. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law.


