The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida pursuant to statute No. 617

ARTICLE I. NAME

The name of the corporation shall be:
Central Christian Assembly Church, Inc.

ARTICLE II. DURATION

The term of existence of the corporation is perpetual.

ARTICLE III. NATURE OF BUSINESS

The corporation will engage in all activities associated with the operation of a Christian Church including, but not limited to, preaching, witnessing, spreading the Gospel of Jesus Christ, ordaining ministers, holding meetings on a regular basis and any other activities deemed necessary to complete the religious, spiritual and moral education of its members.

ARTICLE IV. CAPITAL STOCK

This is a non-profit, non-stock company.

ARTICLE V. INITIAL CAPITAL

The corporation shall begin business with capital in the sum of Five Hundred Dollars. (\$500.00)

ARTICLE VI. DIRECTORS

This corporation shall have three directors initially. The number of directors may be increased or decreased from time to time by the action of the Board of Directors, but shall never be less than three. The incorporator shall appoint the initial Directors for the corporation.

ARTICLE VII. PRINCIPAL AND REGISTERED OFFICE

ARTICLE VIII. AMENDMENT

The corporation reserves the right to amend, alter, change or repeal any provision contained herein in the manner now or hereafter provided by law, and all rights conferred on directors herein are granted subject to this reservation.

ARTICLE IX. MEMBERSHIP


Membership in Central Christian Assembly Church shall be open to all persons who have accepted Jesus Christ as their personal Saviour and are persons of good will and honorable conduct.
