ARTICLES OF INCORPORATION

FOR

PRIMERA IGLESIA BAUTISTA HISPANA DE ALTAMONTE SPRINGS (ADC), INC.

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

This is a Religious Organization which, as an "artificial person" as defined under the USA Corporate Laws, shall be known as "PRIMERA IGLESIA BAUTISTA HISPANA DE ALTAMONTE SPRINGS (ADC), INC", affiliated to the American Baptist Churches, USA. 

