95 APR -7 AM 9:16 We, the undersigned natural persons of the age of twenty-one year of the grate of Florida. or more, at least two of whom are citizens of the State of Florida, action as incorporators of a corporation pursuant to Chapter 617, Florida Statues, adopt the following Articles of Incorporation, do hereby adopt the following Articles for such corporation.

ARTICLE 1 - NAME

The Name of the corporation is: Disabled American Veterans, North Miami Beach Chapter #81, Incorporated

ARTICLE 11 - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of this corporation and the mailing address of this corporation shall be: (Meeting: McDonald Center, 17051 N.E. 19 Avg., N. Miami Beach, Fl.; (Mailing address: P.O. Box #545825 Surfside, Fl. 33154 Approve TIT - Dupposes ARTICLE III - PURPOSES

The purposes for which the corporation is organized is: To uphold the Constitution and laws of the United States, to realize the true American interest and work for the betterment of all wounded, gassed, injured and disabled veterans, to cooperate with the United States Veterans Administration

and all other public and private agencies devoted to the cause of improving and advancing the condition, health and interest of all wounded, gassed, injured and disabled veterans, to stimulate a feelirg of mutual devotion, helpfulness and comradeship among all wounded, gassed, injured and disabled veterans, to serve our comrades, our communities and our country and to encourage in all people that spirit of understanding our country and to encourage in all people that spirit of understanding our country and to future wars. This corporation is limited to such as will qualify it as an exempt organization under Internal Revenue Section 501 (c) (4). This corporation will not, as a substantial part of its activities carry on propaganda or otherwise attempt to influence legislation. This corporation shall not participate in our intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidates for public office.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The qualifications of members and of their admission are in accordance with National Organization Bylaws. The corporation shall consist of every member in good standing or any person who shall become a member in good standing of North Miami Beach, Chapter #81 , Disabled American Veterans, Department of Florida. Pursuant to section 617.0202(d), Florida Statutes, the directors of this corporation are appointed or elected in accordance with the Bylaws of the National Organization and Chapter Bylaws in which a Commander, Sr. Vice Commander, and one or more Chapter Junior Vice-Commanders, and shall elect or appoint an Adjutant and a Treasurer.

ARTICLE V - LIMITATION OF CORPORATE POWERS

The Corporate powers of this corporation are as provided in Section 617.0302, Florida Statues, unless limited as follows:

This corporation is organized under a non-stock basis.
