

ARTICLES OF INCORPORATION OF



American Institute of Architecture Students-Miami Dade Community College-North Chapter, Inc.

The undesigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation

Article 2. Duration.

The duration of the Corporation is perpetual

Article 3. Purposes.

A This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are

One: To foster an appreciation and understanding of the ideas and objectives of the Institute and to promote and forward the same within the territory of this chapter

Two: To emphasize and promote professional, social, and fraternal aspects of student activities on campus

Three: To foster fellowship, cooperation, and unity among members of this chapter, members of the Sponsoring AIA Chapter and other Student Chapters

Four: To encourage Chapter members' understanding of the current and future scope of architectural practice.

Methods to accomplish the above objectives may include but are not limited to the outlined items in Article Nine: Activities of these Bylaws.

- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to

to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted sin such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
