AMENDED ARTICLES OF INCORPORATION OF POLK COUNTY EXTENSION CITRUS ADVISORY COMMITTEE, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not-for-Profit

Corporation adopts the following amendment(s) to its Articles of Incorporation:

ARTICLE II PURPOSE

The purpose of this corporation will be as follows:

- (a) To support Extension Research, Demonstration and Educational programs in the interest of Commercial Citrus, 4-H and Youth of Polk County as the members of the Corporation may deem appropriate.
- (b) To receive, maintain, and hold, by bequest, demise, gift, or otherwise, either absolutely or in trust for any purpose, any property (real or personal), fund or funds, without limitation as to amount or value, to convey such property and to invest or re-invest any principal; and to deal with and expand the income and/or property of the corporation for such Research, Demonstration and Educational activities and in such manner as in the judgment of the membership will stimulate and promote the best interest of the Polk County agricultural community.
- (c) To do all and everything necessary and proper for the accomplishment of the objectives enumerated in its Articles of Incorporation, or necessary, and incidental to the benefit and protection of the Corporation.
- (d) To carry on any lawful business necessary or incidental to the attainment of the objectives of the Corporation as provided by law. In the event of dissolution of the Corporation, all of its property, whether real, personal, or mixed, and wheresoever situated shall be utilized for the purpose of a scholarship fund supporting and beneficial to the Florida agricultural community and industry. Said scholarship fund shall be administered as directed by the Board of Directors or by another organization or a committee as approved prior to such dissolution of the Corporation. None of the property or income of the Corporation shall inure to the benefit of any officer, director, or member of the Corporation.

ARTICLE V OFFICERS

The Corporation shall have the following officers:

- 1. Chairperson
- 2. Vice-Chairperson
- 3. Secretary
- 4. Treasurer

The Chairperson, Vice-Chairperson, and Treasurer shall be elected by the membership. The Secretary shall be appointed by the Board of Directors in accordance with the By-laws. The Chairperson, Vice-Chairperson, Treasurer, and immediate Past Chairperson shall be members of the Board of Directors.

The qualifications, manner and time of selection, duties, and responsibilities of said board of Directors should be published in the by-laws.

ARTICLE VI MEMBERSHIP

The Corporation shall consist of a minimum of 6 members and shall not exceed 12 members. Membership will not be denied any person on the basis of race, creed, national origin or sex. All members will be residents of Polk County, interested in furthering the educational objectives of the Polk County Cooperative Citrus Extension Service.
