**ARTICLE I**

**NAME**

The name of this corporation is: New Life Assembly of God in Miami, Inc.

**ARTICLE II**

**PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business shall be at 165 Lawn Way, Miami Springs, FL 33166 and the mailing address of this corporation shall be P.O. Box 660597, Miami, FL 33266-0597

**ARTICLE III**

**PURPOSE**

The corporation is organized not for profit but for the purpose of diffusing the Gospel of Jesus Christ and the teaching of the Holy Bible. The general nature of the objects and purposes of the corporation shall be to have all lawful powers incidental to corporations of its character, including, in perpetuity, all powers set forth in Chapter 617, "Corporations Not for Profit", Florida Statutes, 617.021, or the corresponding provision of any future Florida Statute as to same and amendment thereto.

**ARTICLE IV**

**MANNER OF ELECTION OF DIRECTORS**

The method of selection, the term of officers and the duties of the Directors, constant with applicable laws, shall be prescribed by the Bylaws of the Corporation.

## ARTICLE V

### LIMITATION OF CORPORATE POWERS

This corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, encumber, sell, convey, and dispose of all such property, to borrow money, execute notes, bonds, and other evidences of indebtedness and secure the same by mortgage and deeds of trust, annuity bonds and other instruments of indebtedness and pay interest thereon, to improve, adapt, and use its property of the income thereof in its religious, educational, benevolent, or social activities, without financial profit of its members, except as may be necessary in the payment of salaries or other compensation for services rendered; the corporation shall have the power to erect and maintain buildings for the worship of God, for training Christian faith and conduct, and for Christian social intercourse, and to acquire or build and maintain residences for the use occupancy of its ministers

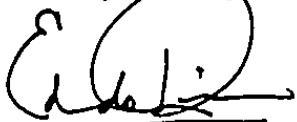
