## Articles of Incorporation

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporations

Article 1

The name of the corporation shall be:

### Article 3

PURPOSES

The specific purposes for which the corporation is organized are:

This non-profit charitable corporation is organized for 501(c)(3) tax exempt purposes with a dual educational and charitable purpose: To serve the public interest of Home Schooling by providing activities for Home School Students (minors) that contribute to educational excellence in academics, athletics, and the arts, and to foster the development of good character through non-denominational religious faith and beliefs. (2) To sponsor and provide the public with a free community outreach program for the prevention of suicide called: Teen Talk Anonymous.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

### Article 4

MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are elected or appointed is as follows:

#### Article 5

#### LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:

This corporation shall have the right to enjoy and utilize all the copyrights and trademarks in connection with, or in association with, Home School Excellence Assn., Inc. or Teen Talk Anonymous, but it shall not have the right to acquire, or sell, or dispose of in any manner whatsoever, such copyright and trademark rights which this corporation acknowledges and agrees are owned by its creators/authors who have reserved all such ownership rights and interest therein or thereunder.

#### ADDITIONAL PROVISIONS

The duration period of this corporation shall be perpetual, and there shall be no formal members.

This non-profit charitable corporation is not organized for the private gain of any person, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof. This corporation's Board of Directors shall perpetually serve in a volunteer capacity without any salaries or monetary compensation of any kind for their time or services rendered. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for educational or charitable purposes, and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in, (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
