## ARTICLE I

CODE.

## ARTICLE IV

### Manner of election of directors

The manner in which the directors are elected or appointed is as follows: ALL DIRECTORS MUST BE MEMBERS OF A BAPTIST CHURCH. THEIR ELECTION SHALL TAKE PLACE AT A MEETING CALLED FOR THAT PURPOSE. BOARD OF DIRECTORS WILL BE MADE UP OF LEADERS OF THE CHURCH OR ELDERS OF THE CHURCH.

ALL FUNDS OF THE CORPORATION AND ANY MONEYS FROM ITS OPERATION SHALL BE USED IN THE FURTHERANCE OF THE PURPOSES SET HEREINAFOVE.




