ARTICLES OF INCORPORATION

OF

D. V. FÜRY LAJOS FOUNDATION CORPORATION

Article 1

This corporation will have perpetual existence.

ARTICLE II

This corporation is organized, and shall be operated exclusively for, charitable, educational, and/or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). Specifically, this corporation is organized to preserve, advance, and promote the legacy of the famous Hungarian writer, novelist, historian, and world traveler, D. V. Fűry Lajos, who authored more than fifty (50) books and several thousand novels, and who made several documentary films for television. The corporation will also strive to preserve and promote the Hungarian language for Hungarian immigrants, and it may conduct any and all worldwide activities intended to foster and achieve an historical and cultural appreciation for all Hungarians, including those attempting to remain free from communism.

The activities of the corporation shall include the generation of financial support for the corporation and its purposes by solicitation of gifts, grants, and donations. The corporation may also engage in various fundraising activities, conduct other independent activities supportive of the corporation and its purposes, invest funds derived from its activities, distribute funds to qualified persons and organizations in amounts deemed proper for the uses and purposes of the corporation, and perform all acts reasonably incident to the foregoing purposes and objectives.

No part of any net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, officers, and directors, or other private persons, except that the entity may provide reasonable compensation for services rendered and may make payments and distributions to further the purposes of the corporation. No substantial part of the corporation's activities shall be the dissemination of propaganda or the attempt to influence legislation. The corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

#### ARTICLE III

The name of the corporation is D v. FÖRY LAJOS FOUNDATION CORPORATION.

#### ARTICLE IV

Membership in the corporation shall be determined by the Board of Directors. The manner in which directors are elected is contained in the bylaws.

#### ARTICLE V

The affairs of the corporation shall be managed by the Board of Directors, consisting of four (4) directors initially. The number of directors may be increased or decreased from time to time in accordance with corporate Bylaws, but shall never be less than three (3). 



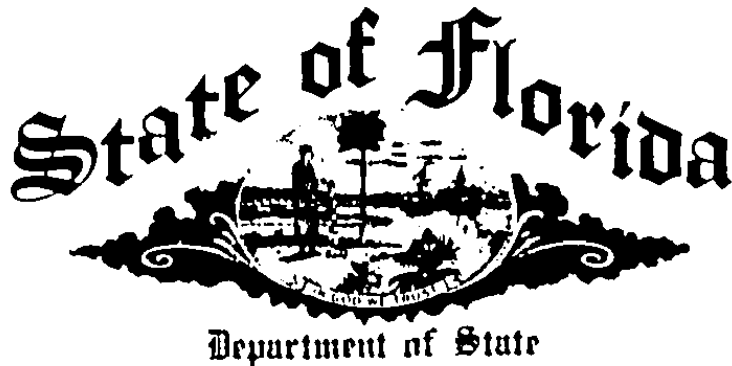
