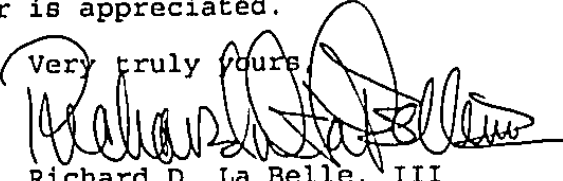

## ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the FLORIDA NOT FOR PROFIT CORPORATION ACT, adopts the following Articles of Incorporation for such corporation:

1. Name. The name of the corporation is Patient Air Lift, Inc.

2. Principal Office/Mailing Address. The principal office of the corporation is 916 Jackson Court, Palm Harbor, Florida, 34683. The mailing address is the same.

3. Commencement of Existence. The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

4. Purpose. The corporation is organized to provide air transportation at no charge to medical patients, based on economic need.

5. Not-for-Profit. This corporation shall be not-for-profit, is organized, and shall act under the applicable laws of the State of Florida governing such corporations.

The above directors shall serve until their resignation or until their replacements are selected in accordance with the procedures set forth in the Bylaws governing selection and service of directors.

9. Bylaws. The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.

10. Amendments. The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.
