The undersigned, each with the capacity to contract, hereby, executes and acknowledges these Articles of Incorporation for the purpose of forming a not-for-profit corporation under and by virtue of the laws of the State of Florida as Contained in Chapter 617, Florida Statutes, and under Chapter 723, Florida Statutes, as amended (the "Acts")

ARTICLE 1. NAME

The name of the corporation shall be: BONITA FAIRWAYS
HOMEOWNERS CORP. The corporation principal office is 9751 West
Terry Street, Bonita Springs, Fl. 33923

ARTICLE 2. DURATION

The date of commencement of corporate existence shall be on the date the Articles are filed with the Department of State, and the period of duration of the corporation shall be perpetual.

ARTICLE 3. PURPOSE AND POWERS

The general purpose for which the corporation is initially organized is to engage in, conduct and carry on the business of operation of a mobile home owners association pursuant to F.S. Chapter 723; the corporation has the power to negotiate for, acquire, and operate the mobile home park on behalf of the mobile home owners; to engage in activities which are necessary,

suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith; and to transact any or all lawful business for which corporations may be incorporated under the Acts. In addition, the corporation shall have all the powers specified in Section 617.071 Florida Statutes. In the event the corporation purchases Bonita Fairways, it shall convert the same to a condominium, cooperative or other type of ownership.

ARTICLE 4 MEMBERSHIP

The members of the corporation are bona fide owners of a mobile home located in BONITA FAIRWAYS, Bonita Springs, in Florida, over two-thirds of which have consented in writing to the formation of the corporation.

ARTICLE 5. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2624 Bonita Fairways Circle, Bonita Springs, Florida 33923 and the name of the initial registered agent of the corporation at such address is Sandy Robinson. I, Sandy Robinson, am hereby familiar with an accept the duties and responsibilities as registered agent for the Bonita Fairways Homeowners Corporation.

ARTICLE 6. DIRECTORS

The initial Board of Directors shall consist of not more than nine (9) members. The names and addresses of the persons who are to serve as directors until the first annual meeting of members or until their successors be elected and qualify, or until their earlier resignation, removal from office or death, are as follows:

Election to the Board of Directors shall be by secret written ballot unless this method is waived by a majority of the members in attendance at the annual meeting. Persons receiving a plurality of the votes cast for that office shall be elected.

Cumulative voting is not permitted. In order to qualify for election to the position of Director, a nominee must be a voting member of the Corporation in good standing. Any vacancy occurring on the Board of Directors for any cause other than the reason of an increase in the number of Directors, may be filled by a majority of the remaining members of the Board of Directors, although such majority may be less than a quorum. Any vacancy occurring by reason of an increase in the number of Directors may be filled by action of a najority of the entire Board of Directors.

ARTICLE 8. PROVISIONS FOR THE REGULATION OF THE BUSINESS AND FOR THE CORPORATION

- 8.1 Meetings of Members and Directors. Meetings of the members and directors of the corporation may be held within the State of Florida at such place or places as may from time to time be designated in the Bylaws or by resolution of the Directors.
- amend the Articles of Incorporation ahall be in the members, but the affirmative vote of two-thirds of the members shall be necessary to exercise that power; except, however, upon the acquisition of the mobile home park and conversion to a condominium, cooperative or other type of ownership, in which event, the affirmative vote of the majority of the members of the Board of Directors shall be sufficient to amend these Articles of Incorporation so that the Corporation shall have all the powers necessary and/or convenient for the operation and management of such condominium, cooperative, or other type of resident/owned mobile home community, including, but not limited to, changing the qualifications for membership in the Corporation.
- 8.3 Bylaws. The initial Bylaws of the corporation shall be adopted by the Directors. The power to amend or repeal the Bylaws or to adopt new Bylaws shall be in the members, but the affirmative vote of the majority of the members shall be necessary to exercise that power; except, however, upon the acquisition of the mobile home park and conversion to a

condominium, cooperative or other type of ownership, the affirmative vote of the majority of the members of the Board of Directors shall be sufficient to amend the Bylaws so that the Corporation shall have all the powers necessary and/or convenient for the operation and management of such condominium, cooperative, or other type of resident/owned mobile home community, including, but not limited to, changing the qualifications for membership in the Corporation. The Bylaws may contain any provisions for the regulation and management of the corporation which are consistent with the Acts and these Articles of Incorporation.

8.4 Contract in Which Directors Have an Interest. No contract or other transaction of the corporation with any person, firm or corporation or no contract or other transaction in which the corporation is interested shall be invalidated or affected by the fact that one or more of the directors or officers is a director or officer of another corporation.

ARTICLE 9. RESTATEMENT IN THE EVENT OF A PURCHASE OF THE PARK

In the event the corporation purchases BONITA FAIRWAYS

Country Club and before the issuance of any cooperative

membership certificate, these Articles may be amended and

restated in order to create a residential cooperative association

under Chapter 719, Florida Statutes by a resolution of the Board

of Directors.
