ARTICLE I

NAME

The name of the corporation shall be Fellowship House Transportation Services Inc

ARTICLE II

PURPOSE

The purpose of this corporation shall be to provide transportion and other transportation related activities.

ARTICLE III

POWERS

This corporation shall have all powers provided in Section 617.0302, Florida Statutes. Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501(c3) of the internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, or (b) a corporation, contributions to which are deductible under Section 170(c2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.

QUALIFICATION AND ADMISSION OF MEMBERS
