ARTICLES OF INCORPORATION OF FOCUS ON CHRIST MINISTRIES, INC.

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation:

Article 1

NAME

The name of the Corporation is: FOCUS ON CHRIST MINISTRIES, INC. The principal place of business of the corporation shall be 2611 Pickett Downs Drive, Chuluota, Florida, and the mailing address shall be P.O. Box 2226, Oviedo, Florida 32765.

Article 2

NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustees, or Officers, except to the extent permissible under law.

Article 3

DURATION

The duration of the Corporation is perpetual.

Article 4

PURPOSES

The Corporation is organized, and shall be operated exclusively for the following purposes:

- A. To receive and administer funds and to operated exclusively for religious, charitable, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or comparable provisions of subsequent legislation (the "Code). Among those purposes is the proclamation of the gospel of Jesus Christ.
- B. To acquire, own, purchase, lease, dispose of and deal with real and personal property and interests, either absolutely or in trust therein and to apply gifts, grants, bequests, and devises and the proceeds thereof in furtherance of the purposes of the corporation.

C. To do such things and to perform such acts to accomplish its purposes as the Board of Trustees may determine to be appropriate and as are not forbidden by Section 501(c)(3) of the Code, with all the power conferred on nonprofit corporations under the laws of the State of Florida.

Article 5

LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Trustees, or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 4 (Purposes) hereof.

Article 6

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial Registered Office of the Corporation is 2611 Pickett Downs Drive, Chuluota, Florida, 32766, and the name of its initial Registered Agent at that address is Fred Franz.

Article 7

INITIAL BOARD OF TRUSTEES

The management of the Corporation shall be vested in a Board of Trustees. The number of Trustees constituting the initial Board of Trustees is three(3). The number of Trustees may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three. The method of election of Trustees shall be set forth in the Bylaws. The name and address of each initial Trustee of the Corporation is as follows:

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FOCUS ON CHRIST MINISTRIES, INC. 96 MAY 15 PM 3: 38

Pursuant to the povisions of Chapter 617, Florida Statutes, this corporadon suppose the STATE following amendment to its Articles Of Incorporation:

Article 11

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

There are no members of this corporation. This amendment was adopted by unanimous vote of the Board of Trustees on May 7,1996.
