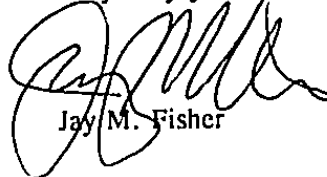

ARTICLE I - NAME OF CORPORATION

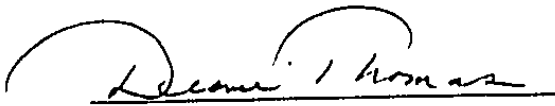
ARTICLE VI - BOARD OF DIRECTORS

ARTICLE VII - AMENDMENT

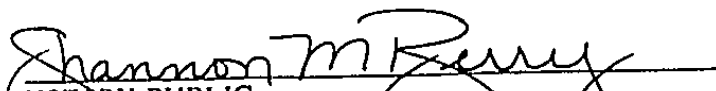

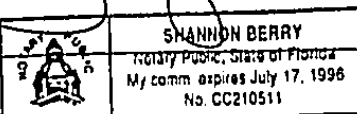

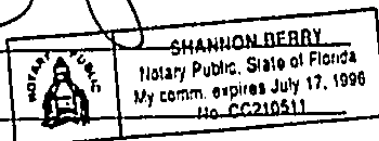
