Articles of Incorporation of Parker Highland East Home Owners' Association Inc.

Article L. Name

The name of this Florida not-for-profit corporation is Parker Highland East Home Owners' Association Inc.

Article II. Address The mailing address of the Corporation is: Parker Highland East Home Owners' Association Inc. 4605 South Ocean Houlevard Highland Beach, FL 33487

Article III. Purpose

The Corporation is organized to foster meaningful, supportive, relations among owners through a social organization; to support the activities of the Highland Park Free Public Library; to establish a liaison between and among all owners; to establish a liaison with municipal authorities, to influence municipal authorities to adopt legislation beneficial to condominium owners; to encourage other condominium associations to organize into a Highland Beach Condominium Association to work for the common good; to explore the possibility of joint purchasing power since we all buy the same products and services higher volume of business usually produces lower per unit cost; to explore the possibility of privatizing certain services that are labor intensive; to establish a liaison with state legislators to advance the interests of condominium owners; to take whatever action is necessary to advance and protect the cause of condominium living; and to engage in all other lawful acts or activities not for pecuniary profit for which references to "Code" are to the Internal Revenue Code of 1986 as amended or to corresponding provisions of future federal tax legislation.

No part of the net earnings of the Corporation shall inure to the benefit of (or be distributable to) its

directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial pan of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise provided in Code Section 501(h). The Corporation shall not participate or intervene in any political campaign (including the publishing or distributing of statements) on behalf of any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities except those permitted to be carried on by a corporation exempt from federal income tax under Code Section 501(c)(3) and which entitle contributors to the Corporation to deduct their charitable contribution under Code Section 170(a).

Article Vil. Hoard of Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three directors. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but may never be less than three. The election of directors shall be done in accordance with the Bylaws. The directors shall be protected from personal liability to the fullest extent permitted by law.
