ARTICLE 1
AUTHORITY

- 1.1 This corporation is formed under the Florida Not for Profit Corporation Act, Chapter 017 of the Florida Statutes.

ARTICLE 2
NAME

- 2.1 The name of this corporation is Florida Academy of Audiology, Inc.

ARTICLE 3
STREET ADDRESS AND MAILING ADDRESS

- 3.1 The street address of the principal office is 4080 Woodcock Drive, Suite 140, Jacksonville, Florida 32207.
- 3.2 The mailing address of the corporation is P. O. Box 5861, Jacksonville, Florida 32247-5861.

ARTICLE 4
PURPOSES

- 4.1 This corporation is formed for the education and advancement of trained and licensed audiologists practicing within the state of Florida. All lawful activities which are incidental to that purpose are authorized.

ARTICLE 5
ELECTION OF DIRECTORS

- 5.1 The directors are to be elected in accordance with the by-laws.
- 5.2 The incorporators shall hold the organizational meeting, and the initial directors will be elected at that meeting.

ARTICLE 6
REGISTERED OFFICE AND REGISTERED AGENT

- 6.1 The street address of the corporation's initial registered office is 4080 Woodcock Drive, Suite 140, Jacksonville, Florida 32207.
- 6.2 The name of its initial registered agent at that address is Nancy N. Green.

- 6.3 A written acceptance of appointment as registered agent is at the end of these articles.

ARTICLE 7

- 7.2 The incorporator(s) is/are the initial member(s), but additional members may be admitted at or after the organizational meeting.

ARTICLE 8
REGULATION OF INTERNAL AFFAIRS

- 8.1 Except as limited by these articles or the Florida Not for Profit Corporation Act, all of the internal affairs of this corporation will be regulated by the by-laws.

- 8.2 The Florida Not for Profit Corporation Act in force at the time of the filing of these articles contains some elective provisions for regulating the internal affairs of this corporation which must appear in these articles in order to be available and binding. Accordingly, the following provisions will apply:

8.2.1 Notice under the Florida Not for Profit Corporation Act or the by-laws may be in any manner permitted by law, including oral.

8.2.2 A quorum of the board of directors may consist of less than a majority but no fewer than one-third of the prescribed number of directors determined under the by-laws.


