The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

**ARTICLE 1 - NAME**

The initial President of the corporation shall be Margo Sloan whose address shall be the same as the principal office of the corporation.




### ARTICLE 13 - EFFECTIVE DATE
