ARTICLES OF INCORPORATION

The Florida State Colony Alumni of the Delta Sigma Phi Fraternity Incorporated

We, Jamie Pimentel and Brian Ray, whose names are here unto subscribed, desiring to form a non-profit corporation under and by virtue of the laws of the State of Florida providing for the formation of religious, benevolent, literary, education, scientific, fine arts, musical, sculptural, engraving, architectural and charitable societies and trade organizations, do hereby associate ourselves together and make and execute, in triplicate, the following articles of Incorporation to wit:

*Article I.* The name assumed by this corporation and by which it shall be known is The Florida State Colony Alumni of Delta Sigma Phi Fraternity, and the duration of the life of this corporation shall be perpetual. *Incorporated*

*Article II.* The object, business and pursuit of this corporation is and shall be: *The purpose of this corporation is as stated above*

To build, acquire, own, exchange, operate, lease, rent or otherwise control a fraternity house in the vicinity of the Florida State University at Leon County, State of Florida.

To borrow money and issue bonds, notes or certificates of indebtedness therefore:

To rent, lease, hold, exchange, own and acquire such real and personal property as may be necessary or convenient for the use of said corporation, and to sell, mortgage, pledge and dispose of the same:

To abide by the *Constitution and Bylaws* of the Delta Sigma Phi national Fraternity:

This corporation assumes to itself and shall possess the rights, powers, privileges and franchises to do anything necessary, convenient and desirable in order to accomplish the purpose here in before set forth, and the rights, powers, privileges and franchises granted or conferred or that hereafter may be granted or conferred, to the like corporation by the laws of the State of Florida.

*Article III.* The estimated value of the property and money possessed by this society at the time of the making of these articles in incorporation is the sum of \$ 0.00 dollars; that the source of the revenue of this corporation shall be derived from the same of real property, from assessments on the Florida State Colony of Delta Sigma Phi Fraternity, and from gifts and donations.
