BY-LAWS of CLASSY CATS SOCIETY

ARTICLE I

The name of this organization shall be the Classy Cats Society.

ARTICLE II

Purpose

The objects of this organization shall be the following: the improvement of the breeds of cats in the area: the promotion of the welfare of the cat: the promotion of the interests of breeders and exhibitors of cats.

ARTICLE III

Membership

Section 1 - Eligibility

The candidate for membership must exhibit a true concern for the welfare and being of all breeds of cats.

Section 2 - Acceptance

On a vote having been taken at a general meeting and a majority of yea votes been counted, the candidate will be accepted as a non-voting member until they have actively worked on a Classy Cats show.

Section 3 - Dues

Dues shall be \$10.00 per person annually, \$15.00 family rate for married couples, payable to the club treasurer at the annual meeting to be held the last weekend of April each year.

Section 4 - Termination

If dues have not been paid within 30 days of due date: any behavior not in the best interest of the purpose of the club: the exhibition of poor sportsmanship: non-participation at the Classy Cats show. Except in the case of an emergency, anyone not working at one show will be put on probation, that is, become a non-voting member. Anyone not working at two shows is automatically suspended from membership.

ARTICLE IV

Meetings

Section 1

An annual meeting will be held every year on the last weekend of April at the Daytona Beach Cat Show.

Section 2 - Special Meetings

The President may call a special meeting at any time upon notice of one week The majority of members in good standing may demand the president call a special meeting at any time.

ARTICLE V

Officers and Elections

Section 1 - Officers

- A. Elective officers shall be President, Vice-President, Secretary and Treasurer.
- B. Officers shall be active members in good standing.
- C. Only one member of a household may hold office at any given time.
- D. Terms of office shall be one year.

Section 2 - Elections

Election of officers will be by secret ballot at the annual meeting held in April at the Daytona Beach Cat Show.

All Classy Cats Society records shall be present at the annual meeting. Club Secretary, Treasurer and anyone else with information or records must see to it that these records are present even if they can not attend the meeting.

ARTICLE VI

Quorum

A quorum shall consist of a majority of the voting members present.

ARTICLE VII

Amendments

These By-Laws may be amended or added to by a majority vote of members present provided that each member has been informed in writing one week in advance of the proposed change or addition.
