NONPROFIT ARTICLES OF INCORPORATION

0F

GESU CATHOLIC CHURCH CENTENNIAL COMMISSION, INC.

THIS IS TO CERTIFY that we, the undersigned, hereby associate ourselves into a corporation not for profit, pursuant to the provisions of the
laws of the State of Florida providing for the formation of a corporation not
for profit, for the purposes, and with the powers hereinafter stated, and too
that we do this certificate set forth.

ARTICLE 1.

The name of this corporation shall be known as:

GESU CATHOLIC CHURCH CENTENNIAL COMMISSION, INC.

with the principal place of business and mailing address to be located at Miami, Dade County, Florida, at 118 North East Second Street, Miami, Florida 33132.

ARTICLE II.

The object of this corporation and its purposes are solely benevolent. It has for its only purpose to celebrate the 100th year of the founding of the Gesu Catholic Church, with religious, charitable, cultural, educational, social events and programs.

ARTICLE III.

Any person who is a member in good standing of the Gesu Catholic Church, or who is taking part in this 100th year anniversary may qualify for membership.

ARTICLE IV.

This corporation not for profit shall have perpetual existence.

A. That upon dissolution or discontinuation of this corporation, all the remaining assets after payment of costs and expenses of such dissolution shall be administered by the Pastor of GESU CATHOLIC CHURCH, in an Endowment Fund, for the continual benefit of GESU CATHOLIC CHURCH.

ARTICLE V.

The elections and appointment of the directors shall be stated in the By-Laws.

ARTICLE VI.
