As voted on by the Board of Directors by a majority vote, a plan of distributing all assets of AMERICAN'S DISABILITY FOUNDATION, INC. at the time of dissolution was adopted and reads as follows:


1. All liabilities and obligations of AMERICAN'S DISABILITY FOUNDATION, INC., will be paid and discharged at the time of dissolution, or as soon thereafter as possible;
2. Any assets held by AMERICAN'S DISABILITY FOUNDATION, INC., upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution of AMERICAN'S DISABILITY FOUNDATION, INC., will be transferred or conveyed to an organization who engages in the same or similar causes as; providing for or raising funds for the disabled for, medical aid relief, provisions for physical necessities or services for rehabilitation, the prevention of suicide, the alleviation of mental or physical health problems, social welfare services which clearly and substantially benefit persons disadvantaged or suffer a hardship due to disability; and medical research for the relief of disability, both mental and physical.
3. Assets received and held by AMERICAN'S DISABILITY FOUNDATION, INC., and are not subject to limitations permitting their use only for AMERICAN'S DISABILITY FOUNDATION, INC., but not held upon a condition requiring return, transfer of conveyance by reason of dissolution




of AMERICAN'S DISABILITY FOUNDATION, INC., may be transferred or conveyed to an organization who engages in the same or similar causes as; providing for or raising funds for the disabled for, medical aid relief, provisions for physical necessities or services for rehabilitation, the prevention of suicide, the alleviation of mental or physical health problems, social welfare services which clearly and substantially benefit persons disadvantaged or suffer a hardship due to disability; and medical research for the relief of disability, both mental and physical.

4. Any remaining and/or all other assets will be distributed to an organization who engages in the same or similar causes as; providing for or raising funds for the disabled for, medical aid relief, provisions for physical necessities or services for rehabilitation, the prevention of suicide, the alleviation of mental or physical health problems, social welfare services which clearly and substantially benefit persons disadvantaged or suffer a hardship due to disability; and medical research for the relief of disability, both mental and physical.
