ARTICLES OF INCORPORATION

OF

A CORPORATION

The undersigned incorporator(s), in order to form a corporation under the laws of the state of Florida, Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ONE: The name of this corporation shall be:

THREE: The purposes and objects of this corporation shall be:

2. To promote the principles of good government and good citizenship.

4. To unite the Clubs in the bonds of friendship, good fellowship and mutual understanding.

6. To encourage service-minded people to serve their community without personal financial reward, and to encourage efficiency and promote high ethical standards in commerce, industry, professions, public works and private endeavors.
7. Generally to carry out at Dundee Central Ridge, the principles and teachings of The International Association of Lions Clubs, a service club organization with whom the Dundee Central Ridge Lions Club is affiliated.
8. That, except as herein limited, this corporation shall have and exercise all the powers granted to corporations by the laws of the State of Florida.
9. To incorporate the unincorporated association known as the Dundee Central Ridge Lions Club.
