ARTICLES OF INCORPORATION

OF

INFORMATION FOR COMMUNITY ACTION NOW, INC.

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statues Chapter 617, do hereby make and adopt the following Articles of Incorporation.

ARTICLE ONE

INFORMATION FOR COMMUNITY ACTION NOW, INC. 2544 ARBORWOOD DRIVE VALRICO, FL 33594

The name of the Corporation is: Information For Community Action Now, Inc. The principal place of business of this Corporation shall be 2544 Arborwood Drive, Valrico, FL 33594.

ARTICLE TWO

NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustee or Officers, except to the extent permissible under law.

ARTICLE THREE

DURATION

The duration (term) of the Corporation is perpetual.

ARTICLE FOUR

PURPOSES

The Corporation is organized, and shall be operated exclusively for, the following purposes:

A. To educate Individuals of the Community regarding affordable housing opportunities.

- B. To improve quality and upgrade the practices of housing for individuals lifestyles by finding affordable housing for individuals who qualify. This may include HUD housing.
- C. To uphold and preserve the dignity of our citizens and to educate society about affordable housing.
- D. To enhance the standing of individuals in need of Affordable housing and its public acceptance.
- E. To deal fairly and justly with clients and members of the profession and condemn all practices and actions which discredit our organization.
- F. To improve qualifications and upgrade the practices of affordable housing.
- G. To further the interests of the organization by a free exchange of information and experience with other members of the association.
- H. To utilize personal knowledge and skills for the greatest good to the Association and the world.
- I. Any other matters concerning individuals and affordable housing.

To exercise all rights and powers conferred by the laws of the State of Florida upon non-profit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount of value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.

J. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE FIVE

LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Trustee or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Four (Purposes) hereof.

ARTICLE SIX

MEMBERS

The Corporation shall have Voting Members who shall be elected (and may be removed) by the Voting Members and shall have all rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
