ARTICLES OF INCORPORATION  
OF  
LION OF JUDAH'S VICTORIOUS CHURCH, INC. 95 APR 26 PM 2:12

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: LION OF JUDAH'S VICTORIOUS CHURCH, INC.

The principal place of business of this corporation shall be: 2603 Coventry Lane, Ocoee, Florida 34761. The Board of Directors may, from time to time, move the principal office to any other address.

ARTICLE II

The period of duration of this corporation is perpetual, unless dissolved according to law, and the commencement of the corporate existence shall be the time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III

The corporation is organized exclusively for:

A. Religious, charitable and educational purposes which include the relief of the poor, the distressed and the underprivileged; advancement of education by providing educational programs, scholarships, forums and, counselling to students, parents and teachers; and the distribution of its funds for such purposes.

B. To operate exclusively in any manner for such religious, charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any other applicable Internal Revenue Law) as amended, or under any corresponding section of any future federal tax code covering the distributions to organizations as tax exempt organizations under the Internal Revenue Code.

#### ARTICLE IV

The qualifications for members and the manner of their admission are to be regulated by the bylaws of the corporation. The manner in which directors are to be elected or appointed is to be regulated by the bylaws of the corporation.

#### ARTICLE V

The number of directors constituting the initial Board of Directors of the corporation is three (3). The number of directors may be increased from time to time by the by-laws but may not be less than three (3). The names and addresses of the persons who are to serve initially are:

#### ARTICLE VI

This corporation is organized under non-stock basis.

#### ARTICLE VII

A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

C. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### ARTICLE VII


Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954, or corresponding section of any prior or future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE IX
