ARTICLES OF INCORPORATION
OF
NATIONAL ORGANIZATION ASSISTING the HOMELESS Corp.

ARTICLE I
C O R P O R A T E N A M E

The name of this Corporation shall be: NATIONAL
ORGANIZATION ASSISTING the HOMELESS Corp.

ARTICLE II
T E R M O F E X I S T E N C E

This Corporation shall have perpetual existence,
commencing upon filing of these Articles.

ARTICLE III
P U R P O S E S

The purpose of the corporation is as follows:

- A. This corporation is not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are; But not limited to, provide the immediate needs [Proper identification, employment and transitional housing] and encourage a continuum of care program for homeless individuals.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE IV

I N I T I A L R E G I S T E R E D A G E N T A N D O F F I C E

The Registered Agent and the street address of the initial registered office of this Corporation in the State of Florida shall be:
