A nonprofit Corporation under the Laws of the State of Florida
pursuant to Chapter 617 of the Florida Statutes and all
amendments thereto.

ARTICLE I-NAME

The name of the corporation is Reinado Internacional
del Mar, Inc.

ARTICLE II-DURATION

The corporation shall have perpetual existence, unless
sooner dissolved in accordance with the laws of the State of
Florida.

ARTICLE III-PURPOSE

The general purpose of the corporation shall be as
follows, to wit:

a) To promulgate, assist and further pageant celebra-
tions of the international community residing in the State of
Florida and to perform other functions associated with the goals
of the organization expressed herein.

President, Executive Director, Secretary and Treasurer.

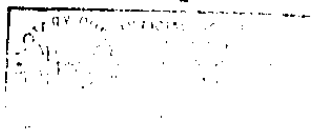
