ARTICLES OF INCORPORATION

of

BURNING BUSH MINISTRIES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Statutes, Chapter 617, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

BURNING BUSH MINISTRIES, INC.

Principal office address is 208 S. Main St., Van Buren, OH 45889.

ARTICLE II

The specific purpose for which this corporation is organized is to establish and maintain churches throughout the United States and to train and ordain. The corporation is organized exclusively for charitable, educational and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

ARTICLE III

The corporation shall not have any capital stock and the conditions of membership shall be stated in the By-laws. The corporation shall expend all of its available resources in the furtherance of its benevolent goals, and has no intention to earn a profit for its members, directors or officers. This corporation shall be a non-profit corporation and will not issue stock, or distribute dividends or other shares of its income or earnings to any individual associated with the corporation. In the event of the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purpose of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational and religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine.

The manner in which directors are elected is as stated in the by-laws.

ARTICLE IV

The name and address of the initial registered agent is: Corporate Access, 1116 D Thomasville Road, Mt. Vernon Square, Tallahassee, Florida 32303.

ARTICLE V - INCORPORATOR


