**ARTICLES OF INCORPORATION
OF
THE COCONUT GROVE FAMILY AND YOUTH
INTERVENTION CENTER, INC.**

A NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Statutes, adopts the following Articles of Incorporation:

FIRST: The name of the corporation is THE COCONUT GROVE FAMILY AND YOUTH INTERVENTION CENTER, INC.

SECOND: The street address of the initial principal office is 3576 Grand Avenue Miami, Florida 33133. The mailing address is P.O. Box 330322 Miami, Florida 33233.

THIRD: The purposes for which this corporation is formed are exclusively charitable, educational and scientific and consist of the following:

1.) To raise the economic, educational and social levels of the residents of Dade County Florida including members of the minority community, who are substantially unemployed, underemployed, or whose income is below federal poverty guideline, to foster and promote community wide interest and concern for the problems of said residents to the end that (a) educational and economic opportunities may be expanded; (b) sickness poverty, crime and environmental degradation may be lessened; and (c) racial tensions, prejudice and discrimination, economic and otherwise, may be eliminated.

2.) To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chest, funds and foundations organized and operated exclusively for charitable, educational or scientific purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda or otherwise attempting to influence legislation.

3.) To do any and all lawful activities which may be necessary useful, or desirable for the furtherance, accomplishment, fostering or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with other, whether such other be persons, or organizations of any kind or nature, such as corporations, firms associations, trusts, institutions, foundations, or governmental bureaus, departments or agencies.

4.) To provide administrative and counseling staff to coordinate and access essential social services, medical needs, and employment opportunities for youth and family members in the Coconut Grove community.

5.) To identify and treat at risk youth in a comprehensive family unit manner by coordinating an early intervention advocacy system consisting of a community-wide network of educational, cultural, recreational and motivational activities in addition to essential social services.

6.) All of the foregoing purposes shall be exercised for exclusively charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

FOURTH: Directors shall be elected and appointed in the manner provided for by the By-laws.

FIFTH: Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

SIXTH: This corporation is organized exclusively for charitable and educational purposes. The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying

out the Corporation's charitable and educational purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.

SEVENTH: No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in , or intervene in, any political campaign on behalf of any candidate for public office.

EIGHTH: Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or any person concerned in the liquidation.

NINTH: In the event that this Corporation shall become a "private foundation" within the meaning of section 509 of the Internal Revenue Code 1954, the Corporation shall distribute its income for each taxable year at such time and in such manner as not to subject it to tax under section 4942 of the Internal Revenue Code; shall not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code; shall not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code; shall not make any investments in such manner as to subject it to tax under section 4944 of the Internal Revenue Code; and shall not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code.

TENTH: The address of the Corporation's initial registered office 3576 Grand Avenue Miami, Florida 33133. The name of the Corporation's initial registered agent is Yvonne McDonald.

ELEVEN: The name and address of the incorporator is: The Coconut Grove Local Development Corporation, Inc., P.O. Box 330075 Miami, Florida 33233-0075.

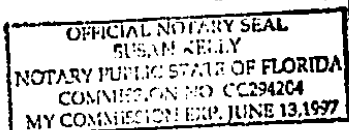
