#### ARTICLES OF INCORPORATION

# LLOYD AREA COMMUNITY ENHANCEMENT ORGANIZATION INC.

A NON-PROFIT CORPORATION
BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation under Florida Law.

#### NAME

The name of this corporation is the Lloyd Area Community Enhancement Organization, Inc.

# DURATION

The term of existence of the corporation is perpetual.

# **PURPOSE**

The purpose of this corporation is to serve the Community of Lloyd. It will operate and organize exclusively for charitable, educational, and social purposes, and to engage in community activities: visual beautification, promotion of social and educational events, and provide a viable link between citizens and businesses.

# **MEMBERS**

The qualifications for members of this corporation and their admissions shall be regulated by the bylaws.

This corporation shall issue no stock. No part of the net earnings of this corporation shall accrue to the benefit of nor be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to it under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, or to a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law. On the dissolution of this corporation.

# DIRECTORS

This corporation shall have a board of directors of four directors initially. The number of directors shall be prescribed in the bylaws from time to time. The names and addresses of the directors who shall serve until the election are:

#### **BYLAWS**

The bylaws of the corporation shall be adopted by the board of directors.

# **AMENDMENTS**

An amendment to these articles may be proposed by the board of directors or a member. Amendments shall be adopted by the board of directors by the affirmative vote of at least three-fourths of the directors present and voting at a meeting at which a quorum is present.

# RESIDENT AGENT

The initial resident agent for this corporation is Joyce Peterson, and initial resident office is located at Route 4, Box 4539, Monticello, Florida 32344.

This is also the principal address of the corporation.

the board of directors shall dispose of all assets of this corporation exclusively either to further the aforesaid purposes of this corporation, or to another corporation or corporations that shall at the time qualify as exempt organizations under Sections 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of the corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction exclusively for these purposes or to the organizations that the court determines are organized and operated exclusively for the aforesaid purposes.
