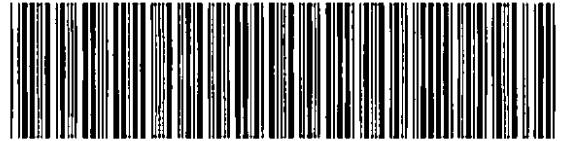

emblems shall be permitted to be placed in or upon any part
of the Cemetery. And if any effigy, monument or any structure
whatsoever, or any inscription be placed in or upon a plot, the
Cemetery committee shall have the right, and it shall be their
duty, to enter upon such plot and remove the offensive or
improper object. If the removal of such object incurs any cost,
the burial right owner shall be liable for any and all costs.
