## ARTICLE OF INCORPORATION OF SCOTT LAKE PROPERTY OWNERS ASSOCIATION INC.

We, the undersigned, with other persons being desirous of forming a corporation for charitable and philanthropic purposes under the provisions of Chapter 617.1006 of the Florida Statues, the undersigned corporation adopts the following Articles of Incorporation.

- Article I Name: The name of the corporation shall be Scott Lake Property Owners Association Inc.
- Article II The general nature of the objects and purposes of this corporation shall be:
- (A) <u>Specific</u>
  The purpose for which the association is organized are exclusively charitable, scientific, literary, educational., and community neighborhood development, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- (B) The Association shall engage in all activities that enhance the local neighborhood in which the association is established. The development of program and service that assist all homeowners in maintaining a clean, safe and beautiful neighborhood.

Any such assets not so disposed of shall be disposed of by the Court of Common Pleas, of the Court in which the principal office of the organization is then located, exclusively for such purpose.

#### Article III Qualification of Member

The membership of this Association shall constitute all person person herein after named as subscribers and such other persons that own homes in the Scott Lake Community of which is described in the By-Laws of Association.

Article IV Terms of Existence

The corporation is to exist perpetually.

Article V Officers, Management
