ARTICLES OF INCORPORATION

The undersigned, acting as an incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purposes for which the corporation is organized are: A foundation supporting marine youth activities, to receive and expend funds in order to train young people in the proper techniques for marine endeavors and activity and activities or any other purpose allowed by the laws of the State of Florida.

ARTICLE IV




