ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 610, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I Name

The name of the corporation shall be ASAMBLEA CRISTIANA DEL SUR DE LA FLORIDA, INC. (Christian Assembly of South Florida, Inc.)

ARTICLE II Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be 4623 10th Avenue North Lake Worth Florida, 34633

ARTICLE III Purpose(s)

The specific purposes for which the corporation is organized are:

- 1 To provide an environment where Christians can nurture and encourage one another according to the teachings of the Bible.
- 2 To obey the Lord Jesus Christ by continuing the ordinances of water baptism and the Lord's Table (communion).
- 3 To provide resources and personal for any endeavors that proclaim the gospel to the world and to help minister to the physical needs of the members who have a real need and after these the needs of non-members.
- 4 To preserve the faith originally entrusted to the apostles and early disciples.

 - b. Not to allow what the Bible prohibits.
- 5 To recognize those men that God raises up as spiritual shepherds among us - called elders in the New Testament - and those who oversee material needs - deacons.

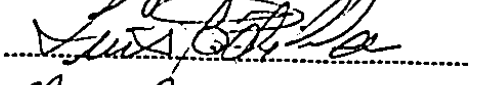


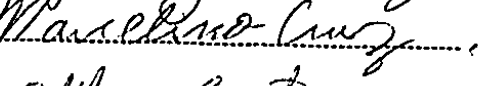
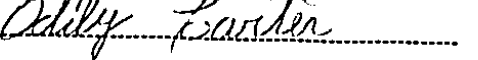
