To promote a response by the general public and state and county leaders to the diseases of alcoholism and drug abuse; to cooperate with official and voluntary health, welfare, educational, and rehabilitation agencies concerned with the prevention, control, and treatment of individuals afflicted with the physical, emotional, or mental problems of alcohol or drug abuse: to better serve those who are afflicted and their families; to encourage the organization of professional alcoholism and/or drug abuse counselors throughout the state; to examine. endorse, and encourage competent and comprehensive programs for the education of alcoholism and drug abuse counselors; to conduct state conventions, state conferences, area seminars, and local educational programs to increase the competence and knowledge of individual members and the general public, and be empowered to engage in such other and further means as may be necessary and proper to accomplish the foregoing objectives and purposes.

The Board of Directors shall be composed of the officers of the corporation and the immediate past president of the corporation, who shall be nominated by the Nominations and Elections Committee and elected by the majority vote of the voting members of the corporation.
